- o Submission must be in paper format, minimum size of 4" x 6", and digital version (preferably a jpg file)
- o Photo must have been taken by contest entrant (limit of 4 photos submitted per person per contest)
- o Photo and entry form (1 entry form for each photo submitted) must be submitted in a sealed envelope. All entries must be received at the Wild and Scenic Office, 2839 VT Route 105, East Berkshire, VT 05447, no later than 4 pm, December 1, 2011
- o All photos submitted become the property of the Upper Missisquoi and Trout Rivers Wild and Scenic Study for the purpose of promoting the Upper Missisquoi and Trout Rivers Wild and Scenic Study
- o The Study Committee reserves the right to reject submissions it considers inappropriate
- o Winners will be announced in our next newsletter following the December 1 deadline. Only the grand prize winner receives the message.
